Dear Redistricting professionals for Alameda County,

Speaking only for myself as a resident of Alameda County, I would like to submit this map that - based upon my understanding - would meet the requirements of the Fair Maps act with the key assumption that each of the twenty-one Alameda County Cities and Census Designated Places would individually be treated as a Community of Interest (COI).

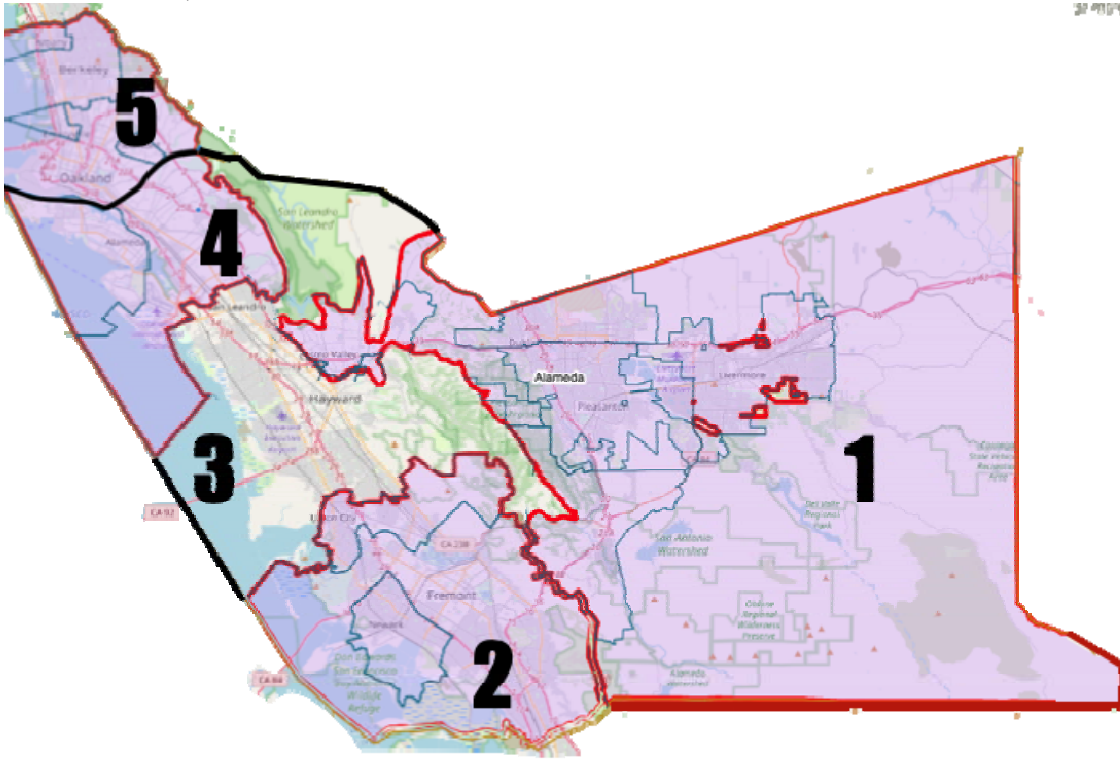
In this scenario, Oakland, which must be divided anyway, is divided only into two districts. The county staff would need to drill down to another level of detail to determine where best to divide Oakland between District 5 and District 4 based upon this suggested division of populations outlined in the chart below with consideration for the more detailed COIs submitted by Oakland residents.

Applying the data from the released Oct 25th county population chart (included below), this is how **the Cities & CDP's as COIs** could be organized into five equal districts (within the +/- 5 percent accuracy) where the target "equal" district size of 336,694:
